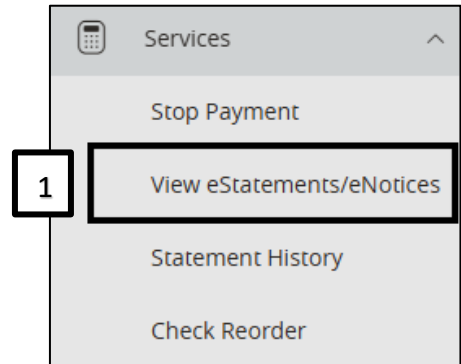
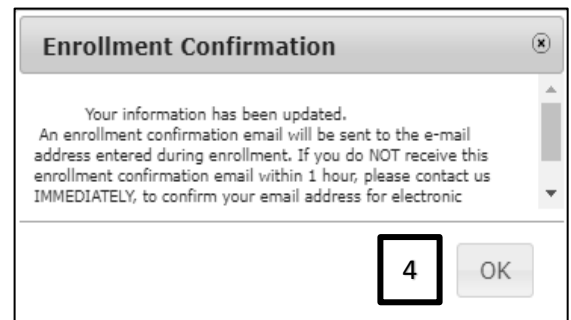


- From the Services menu select 'View eStatements/eNotices' feature.

- You will receive an **enrollment confirmation** by email. The email will be sent to the email address entered during enrollment.




- Check the appropriate box to **enroll accounts and documents**.




2. Once the documents available for those **accounts load**, then select one or more **documents** and select **Download**.
